## **Exciting Day in Lansing - Pro Life Bills Voted On**

As prolife representatives from the Tri-Cities area traveled to Lansing to attend Legislative Day on a beautiful sunny morning, dodging construction zones, we were full of anticipation for the day, knowing that the Senate Bills 229 & 230 along with House Bills 4320 & 4321, which are the Dismemberment Abortion Ban Bills would be coming up for a vote. Speaker of the House, Rep. Lee Chatfield gave a faith filled talk on the importance of

staying focused on removing the legality of abortion. Tri Cities was well represented with pro life adults and students.

During lunch the good news was announced that the Senate Bills had been passed. Dr. Monica Miller joined us to share her experiences of giving testimony during the committee hearings on the Dismemberment Ban Bill and her long history of exposing the realities of abortion clinics. When

our meeting ended, we walked to the Capital building. We sat in the gallery of the House Chamber and listened as the Representatives spoke on the pros & cons of the bill. The vote on our bills happened around 4:30pm and passed by a 58 - 51 margin. Our first time experience to witness a bill introduced on the floor, debated and voted on. The process was lengthy but well worth the wait.

# Abortion is in the news every day as states challenge the *Roe v Wade* Court decision

Conservative states are attempting to pass laws they hope will make the US Supreme Court challenge Roe v Wade. Liberal states are passing laws to repeal as many abortion restrictions as possible in fear the court will return the abortion issue to the states.

The Roe v Wade decision was passed by the US Supreme Court in 1973. This federal law allows a woman to select abortion to end her pregnancy, at any time from conception through all 9 months until the birth of the baby.

Some facts about the State of Michigan abortion laws.

- We are one of only 8 states who have a pre-Roe ban of all abortion with the exception of the life of the mother. Our law has been in place since 1846 (MCL 750.14).
- The Michigan Supreme Court confirmed that it is the policy of the State of Michigan to prohibit abortion except to save the life of the mother and that this existing law is constitutional but under the constraints of Roe v. Wade.

## 'dismemberment vs. Heartbeat'

### Bills?

The Dismemberment abortion **procedure** (also known as a D & E/dilatation and evacuation abortion) is the most frequently used 2nd and 3rd trimester procedure.

In 2018, there were 1,908 dismemberment abortion procedures in Michigan, that's 4 to 5 every day. 98% occurred in the 2nd trimester (13 to 24 weeks).

"Dismemberment" is the simplest way to describe this barbaric **procedure**. The doctor inserts grasping forceps through the woman's cervix into the uterus to grab the baby and remove the baby limb by limb. The baby dies just as a human adult or child would: He/ She bleeds to death as the baby is torn apart. The skull is then crushed and removed from the uterus.

The Dismemberment Abortion procedure Ban bills that passed out of the House and Senate on Legislative Day (pg. 1) is an amendment to the existing Michigan

Partial Birth Abortion procedure ban.

This is a ban on this specific abortion procedure.

When passed, the Dismemberment Abortion **Procedure** Bill could be in effect as early as the 1st quarter of 2020.

Right to Life of Michigan is prepared to pursue using Michigan's citizens initiated legislative process. This will involve a signature petition initiative.

The Michigan pro life community will need to collect over 340,000 signatures of registered voters during a 180 day period beginning in July.

The Heartbeat Bill has been introduced by a different prolife group. This bill does not have any impact on the Dismemberment Abortion Procedure Bill.

The Heartbeat Bill can only have an impact in the future after the Roe v Wade decision is overturned.

When this happens, thankfully, Michigan already has a law in effect, (MCL 750.14) with only the constraints of *Roe v Wade* to hinder it.

The Heartbeat Bill sounds like a good thing, but in reality it allows abortion to be legal in Michigan until a licensed medical professional determines a heartbeat.

To simplify, the Heartbeat Bill is going to complicate the enforcement of our existing pre-Roe ban of all abortion with the exception of the life of the mother.
